Descriptions of Trustee Zone boundaries (Updated: May 2011).

Zone 1

Beginning the intersection of the Malad River and US Hwy 30, thence east following the Malad River to the centerline of Sec 35 Twp. 6S R13 EBM, thence north 1 mile to centerline of Sec 26 Twp. 6S R13 EBM, thence east approximately 3 miles to NE corner of Sec 29 Twp. 6S R14 EBM, thence south 2 ½ miles, thence east 1 mile to NE corner of Sec 10 Twp. 7S R14 EBM, thence south 1 mile to SE corner of Sec 10 Twp. 7S R14 EBM, thence west 1 ¼ miles to N center line of Sec 16 Twp. 7S R14 EBM, thence south 2 miles to S centerline of Sec 21 Twp. 7S R14 EBM, thence east ½ mile to NE corner Sec 28 Twp. 7S R14 EBM, thence south to Hagerman Hwy, thence west approximately 3 miles on the Hagerman Hwy becoming 2900 South to Billingsley Creek, thence northerly following Billingsley Creek to US Hwy 30, thence north following US Hwy 30 to the Malad River, which is the point of beginning.

Zone 2

Beginning on the northern district boundary on the Malad River and its intersection with US Hwy 30, thence south following US Hwy 30 to Billingsley Creek, thence southeasterly following Billingsley Creek to the intersection of 2740 South, thence west approximately ½ mile to 1050 East, thence north on 1050 East to 2700 South, thence west on 2700 South to East Ave. South, thence north on East Ave. South becoming East St. to Us Hwy 30, thence southwesterly on US Hwy 30 to Valley Rd., thence west on Valley Rd to Bell Ditch, thence northeasterly following Bell Ditch to Pioneer Rd., thence west on Pioneer Rd. extended to the Snake River, thence north following Snake River to intersection of the Malad River, thence east following the Malad river to US Hwy 30, which is the point of beginning.

Zone 3

Beginning on the Snake River at its intersection with the west extension of Pioneer Rd., thence east on Pioneer Rd to the intersection of Bell Ditch, thence southwesterly following Bell Ditch to Valley Rd., thence east on Valley Rd. to intersection of US Hwy 30, thence northeasterly to East Rd., thence south on East Road to Main St., thence west on Main St. to State Rd., thence south on State Rd. to 2700 South, thence west approximately 2 miles on 2700 South extended west to the Snake River, thence northerly on the Snake River to the intersection of Pioneer Rd., which is the point of beginning.

Zone 4

Beginning on the Snake River at its intersection with the west extension of 2700 South, thence East approximately 2 miles on 2700 South to US Hwy 30, thence southeasterly approximately 2 miles on Hwy 30 to 2925 South, thence east on 2925 South to 1050 East, thence southeasterly on 1050 East to 3000 South, thence east on 3000 South to 1225 East, thence north on 1225 East to 2900 South, thence east on 2900 South becoming Hagerman Rd. to 1400 East, thence south on 1400 East to 3000 South, thence west to 1300 East, thence south on 1300 East to 3125 South, thence west then north on 1200 East, thence west on 3100 South to intersection of the Snake River, thence south following Snake River to SW corner of Sec 17 Twp. 8S 14 EBM, thence west 3 miles along the South School District Boundary to the SW corner of Sec 14 Twp. 8S 13 EBM, thence north 2 miles to SW corner of Sec 2 Twp. 8S 13 EBM, thence west 2 miles to SW corner of Sec 4 Twp 8S 13 EBM, thence north 1 mile to NW corner of Sec 4 Twp. 8S 13 EBM, thence east to the intersection of the Snake River, thence northerly to intersection of Snake River and 2700 South extension, which is the point of beginning.

Zone 5

Beginning at the intersection of State St. and Main St. in the city of Hagerman, thence east on Main St. to East Rd, thence south on East Rd. becoming East Avenue South to 2700 South, thence east on 2700 South to 1050 East, thence south ½ mile to 2740 South, thence east on 2740 South to Billingsley Creek, thence south following Billingsley Creek to 2900 South, thence east on 2900 South and Hagerman Rd to 1225 East, thence south then southwesterly on 1225 East to 3000 South, thence west on 3000 South to 1050 East, thence northwesterly on 1050 East to 2900 South, thence west on 2900 South to US Hwy 30, thence north on US Hwy 30 becoming State St. to Main St., which is the point of beginning.
