REGULAR MEETING OF THE SCHOOL BOARD HELD JANUARY 12, 2011

The regular meeting of the Board of Trustees of the Hagerman Joint School District No. 233, Gooding and Twin Falls Counties, Idaho, was convened at 7:00 p.m. on the 12th day of January, 2011, in the Media Center of the Hagerman Jr/Sr High School, Hagerman, Idaho, pursuant to authority provided by ID Section 33-510.

A. CALL TO ORDER

The meeting opened at 7:03p.m. with Chairman Mark Daily presiding.

B. ROLL CALL & VISITORS

Present were Chairman Mark Daily, Vice Chairman Karl Emerson, Treasurer Harry DeWolfe, and Trustee Chuck Steele. Trustee Becci Tupper was absent. Also present were Superintendent Ron Echols, Principal Mark Kress, Principal Robin Windes, and Clerk Bette Reed.

C. CONSENT AGENDA

<u>Motion</u> (DeWolfe/Emerson) Carried to accept the consent agenda as presented. (discussion: US Bank-bond payment of interest)

D. REPORTS

- 1. Superintendent Ron Echols:
 - Discussed budget proposals presented by Tom Luna.
 Laptops to all freshmen by year 2012; required to take 2 on-line classes to graduate; pay performance for teachers and administrators; update to technology, clickers for classrooms were a few of the items discussed.

2. Principal Mark Kress:

- Dual credit allow students to earn associates degree by time they graduate from high school. Some students will graduate early which could result in less support from the state department;
- Ag students did well at Phoenix, AZ judging competition. Billy Arriaga and Tucker DeMaray came back with full ride scholarship at CSI Ag Program;
- White bus made trip without any incidents;
- Received letter from Red Cross pertaining to blood drawing donations with goal of 40-50 pints;
- New state standard policy of Jr High student's retention if not meeting 80% of core class passing grades. Mr. Kress has implemented a new class to help students in jeopardy of being retained;
- Case Zuiderveld receive an almost perfect ACT Test score in science (missed only 1 question) and also a high grade in math;
- Boys basketball parents raised money to pay for majority of bus trips within the 50 mile radius.
- 3. Principal Robin Windes:
 - SIOP coach Katie Bubock at elementary school Jan. 11, 2011;
 - Katie Bubock will also present a workshop titled "A Framework for Understanding Poverty" on January 14 and February 18, 2011. Stipends and university credit will be available for participants.

4. Director AJ Perkins:

Presented information on overnight field trip for special education junior and senior students March
7-8, 2011. Message of the conference is "There is Life After High School". A stipend is available
from Dept of Ed to pay for hotel, transportation and some of the meals. Possibly will take 7 students
and would like to do the trip every 2 years. Mr. Perkins will come back to later board meeting with
more details and approval.
