1. Superintendent Ty Jones:
 - State Dept of Education Food Service Review on February 11, 2014;
 - Possibility of receiving \$50,000 from state legislature for budget. Will need approximately \$10,000 to \$20,000 additional to balance the 2014/2015 budget;
 - Ms. Leija has done an excellent job on test scores and having 2 sessions of kindergartners;
 - May budget for an additional first grade teacher at \$40,000
 - Wednesday Inservice will be on Common Core.

 - Looking into Idaho Power rebate for light fixture replacements in gym;
