HAGERMAN JOINT SCHOOL DISTRICT NO. 233 REGULAR MEETING OF THE SCHOOL BOARD HELD FEBRUARY 8, 2017

The regular meeting of the Board of Trustees of the Hagerman Joint School District No. 233, Gooding and Twin Falls Counties, Idaho, was convened at 7:00 p.m. on the 12th day of February 8, 2017, in the Media Center of the Hagerman Jr/Sr High School, Hagerman, Idaho, pursuant to authority provided by ID Section 74-206.

A. CALL TO ORDER

The meeting opened at 6:00 p.m. with Chairman Karl Emerson presiding.

B. SWEARING-IN OF TRUSTEE, ROLL CALL and VISITORS

Appointed Trustee Bryan Whitmarsh from Zone recited the Trustee Oath of Office..

Present were Chairman Karl Emerson, Trustee Angie Lauritzen, Trustee Teri Dorchuck and Trustee Bryan Whitmarsh. Vice Chairman Mark Daily entered the meeting late. Also present was Superintendent Mark Kress and District Clerk Bette Reed. Principal Tyler Mills entered the meeting late. Visitors signing the guest list was A.J. Perkins. Also present were boy scouts from Troop 108 earning their Community/Communication Badge.

C. CONSENT AGENDA

<u>Motion</u> (Dorchuck/Lauritzen) Carried to accept the consent agenda as amended to add Resignations as item 1a. (questions-purchase order from amazon for a Ubiquiti RocketM900 (tech supplies), purchase of flashdrives and their use, costs of senior projects.)

D. REPORTS

1. Superintendent Mark Kress:

- Explained to boy scouts requirement of having 4 versus 3 trustees at a board meeting;
- Received SDE Transportation Review and all went very well.
- SDE Child Nutrition conducted the review of the Hagerman Food Service Program and it did not go as well. Lynda
 Westphal from SDE discussed food items that should be in a vending machine but in reality the USDA cannot
 give a directive of items to be sold;
- Purchase of fuel for the Kubota tractor and 4-wheeler higher than usual due to amount of snow removal during the month. One student stepped off the 'cleared' sidewalk onto snow, slipping and breaking his shoulder blade;
- Water flooding issues in the elementary school's library and technology #1 room.
- Board packet has a 2017/2018 school calendar for review. Considering have a Flex Day on the first day of school (8/21/17) for grades 5-12 (possibly include grade 4) to go to Stanley Basin to view the Total Solar Eclipse. Still working on details such as solar glasses or making solar eye boxes. The calendar also added 1 minute to each period (7 minutes) which equates to 2 contract days.

Trustees questioned homecoming week and vending machine requirements.

2. Principal Tyler Mills:

- Visited with the local building inspector and was informed that he would need to contact the state building inspector along with the need of architect drawings to remodel the proposed administrative area;
- A STEM day presented by the Discover Center (free) will be next Tuesday. Couple of the programs being presented will be "Airplane to the Moon", "Stop Rockets", and various science experiments.
- Will come to the next board meeting with a proposal to increase coaching salaries. Hagerman ranks as lowest among schools questioned.

3. Other - Special Education Review

Special Education Director AJ Perkins commented on the File Review of 3 student files. There were a few errors found such as software programming errors, missing a checkbox on graduating student's IEPs, and change on IEPs of listing student's disabilities at end of report. SpEd teacher Lynn Arriaga and SpEd secretary Robin Plank have also been involved on these IEP changes. There is a 90-day window for corrections in which they will then be receiving a letter as "meeting eligibility".

1. J&N Bus Co.

Present was Jerome Fiscus and Tom Baker. Discussion held on upcoming contract extension. They would like to reduce the number of buses required since there was reduction in school days and bus routes which results in fewer miles being driven. Also of concern was the average age of the fleet and the age requirement of the oldest bus.

District Clerk Reed was directed to contact other school districts to get an average age of fleets & age of oldest bus with other bus contractors.
