## REGULAR MEETING OF THE SCHOOL BOARD HELD June 14, 2011

The regular meeting of the Board of Trustees of the Hagerman Joint School District No. 233, Gooding and Twin Falls Counties, Idaho, was convened at 7:00 p.m. on the 14<sup>th</sup> day of June, 2011, in the Media Center of the Hagerman Jr/Sr High School, Hagerman, Idaho, pursuant to authority provided by ID Section 33-510.

#### A. CALL TO ORDER

The meeting opened at 7:05p.m. with Chairman Mark Daily presiding.

#### B. ROLL CALL & VISITORS

Present were Chairman Mark Daily, Vice Chairman Karl Emerson, Treasurer Harry DeWolfe, Trustee Becci Tupper, and Trustee Chuck Steele. Also present were Principal Robin Windes and Clerk Bette Reed. Superintendent Ron Echols and Principal Mark Kress were absent due to school business.

<u>Motion</u> (Tupper/Steele) Carried to accept the consent agenda as presented. (questions on boiler insurance from Moreton Insurance, amount owing to Pacific Steel; liability on new level of Crow's Nest and bar-b-que trailer being built.
