REGULAR MEETING OF THE SCHOOL BOARD HELD JUNE 9, 2015

The regular meeting of the Board of Trustees of the Hagerman Joint School District No. 233, Gooding and Twin Falls Counties, Idaho, was convened at 7:00 p.m. on the 9th day of June, 2015, in the Media Center of the Hagerman Jr/Sr High School, Hagerman, Idaho, pursuant to authority provided by ID Section 33-510.

A. CALL TO ORDER

The meeting opened at 7:00pm with Chairman Karl Emerson presiding.

B. ROLL CALL

Present were Chairman Karl Emerson, Vice Chairman Mark Daily, Treasurer Harry DeWolfe, Trustee Chuck Steele, and Trustee Monte Osborne. Also present was Superintendent Eric Anderson, Principal Mark Kress and District Clerk Bette Reed.

Visitors included Vicki Owsley, Matt Cottam, Angela Lauritzen, Daniel Knapp and Leslie Priebe.

Trustee Harry DeWolfe submitted his resignation as Trustee for Zone 1. The Board thanked him for his years of service and presented him with a parting gift.

C. CONSENT AGENDA

<u>Motion</u> (Daily/Osborne) Carried to approve the consent agenda as amended. (added legal representation from law firm of Moore Smith Buxton and Turcke; question-DrEd car rental payment to Mark Kress, cost of 6 grade orientation, fuel reimbursement to Greg Wood, and Hagerman Valley Spring Water costs for bottled water).

D. BUDGET HEARING

Budget Hearing was postponed to June 22, 2015 at 5:00pm due to the non-publication error made by the Times News newspaper.

Discussion ensued about the lack of savings built into the budget according to earlier reports of the savings. Chairman Emerson would like to see a minimal of \$75,000 in the contingency reserve earmarked to go towards the fund balance. Clerk Reed expressed that the savings from the various areas (salaries/benefits) have been built into the budget but that it was spread out over the various funds and not entirely in the general fund. The administration will prepare a spreadsheet detailing the savings as presented in earlier board meetings.

- 1. Superintendent Eric Anderson:
 - Paperwork has been submitted to the Department of Education for the Teacher Evaluation policy reflecting the Proficient/Distinguished Teacher Ratings;
 - Passed out worksheet on the K-3 student growth for reading and math;
 - Discussed various professional development plans for the 2015/2016 school year. (Strategic Planning, Summer Leadership, Regional Math, Common Core);
 - Discussed the new Milepost software program which tracks student growth utilized by the teachers. Majority of the cost will be paid by special funding from the state department.

2. Principal Mark Kress:

- Passed out new graduation requirements that tie into the new jr/sr high class schedule beginning with the 2015/2016 school year;
- Discussed the Fast Forward and 8 in 6 programs where students can earn either college credits or additional credits to graduate early.
- Football Camp will be hosted by Hagerman School with teams coming in from Camas, Castleford and Dietrich. Hoping to earn around \$450 which will pay for the paint on the football field.
