# HAGERMAN JOINT SCHOOL DISTRICT NO. 233 ANNUAL MEETING OF THE SCHOOL BOARD HELD JULY 12, 2011

The regular meeting of the Board of Trustees of the Hagerman Joint School District No. 233, Gooding and Twin Falls Counties, Idaho, was convened at 7:00 p.m. on the 12<sup>th</sup> day of July, 2011, in the Media Center of the Hagerman Jr/Sr High School, Hagerman, Idaho, pursuant to authority provided by ID Section 33-510.

# A. CALL TO ORDER

The meeting opened at 7:00 p.m. with Superintendent Ron Echols presiding.

#### B. REORGANIZATION OF BOARD

#### 1. Election of Officers

Supt. Echols opened the floor for nominations of Chairman of the Board.

Trustee Steele nominated Trustee Karl Emerson. Trustee DeWolfe nominated Trustee Mark Daily. Secret ballots were collected. Votes: 3 for Trustee Emerson, 2 for Trustee Daily. Motion (Steele/White) Carried to elect Trustee Karl Emerson as Chairman of the Board.

Trustee Karl Emerson was declared Chairman of the Board.

Supt. Echols surrendered the meeting to Chairman Karl Emerson.

Chairman Emerson opened the floor for nominations of Vice Chairman of the Board. Trustee Steele moved, 2<sup>nd</sup> by Trustee DeWolfe to nominate Mark Daily as Vice Chairman. Vote: Carried. Trustee Mark Daily was declared Vice-Chairman of the Board.

Chairman Emerson opened the floor for nomination of Secretary/Treasurer of the Board. Trustee Daily moved, 2<sup>nd</sup> by Trustee White to nominate Trustee Harry DeWolfe as Secretary/Treasurer. Vote: Carried. Trustee Harry DeWolfe was declared Secretary/Treasurer of the Board.

<u>Motion</u> (Steele/Daily) Carried to continue with a check-signature stamp of the Chairman and Vice Chairman (Emerson/Daily) and signature of Clerk Bette Reed.

<u>Motion</u> (Daily/DeWolfe) Carried to continue with posting places at Hagerman Post Office, Hagerman Jr/Sr High School, and Hagerman District Office (Elementary School). Additional posting places may be Chappels Market, Oasis, and City Office.

<u>Motion</u> (Steele/White) Carried to retain auditor Tim Folke. Discussion held on legal representation from Idaho School Board Association.

<u>Motion</u> (DeWolfe/Steele) Carried to allow over-night trips for extra-curricular activities involved in state competitions.

#### C. ROLL CALL & VISITORS

Present were Chairman Karl Emerson, Vice Chairman Mark Daily, Treasurer Harry DeWolfe, Trustee Kim White, and Trustee Chuck Steele. Also present were Superintendent Ron Echols and Clerk Bette Reed. Visitors were Stormi McCarthy with daughter Billei Lyn, Angel Beutler, AJ Perkins, Angie Lauritzen, and Anna Ray.

# D. CONSENT AGENDA

<u>Motion</u> (Daily/White) Carried to accept the consent agenda as presented. Questions about bills from Waxie (custodial supplies), IASA (dues for Echols, Kress, and Windes), and Scientific Learning (Fast ForWord program). Mr. A.J. Perkins presented information on the Fast ForWord program. This is a program which targets kid's abilities. Costs approx. \$15,000 for 13 licenses which will be shared among students at semester/trimester breaks.

#### E. REPORTS

- 1. Superintendent Ron Echols:
  - Floor tile job is ahead of schedule asbestos abatement has been done and now waiting for floor to 'cook' before laying the new tile.
  - Crow's Nest and trailer built by Dan Knapp and students has been approved by agent from Moreton Insurance. Mr. Knapp only needs to install a surge brake lock onto the trailer. Question as to whether or not Mr. Knapp will be using trailer for fundraisers.
  - Kubota tractor should be on-site within a few weeks;
  - State Dept of Ed 'Pay Performance' must be implemented and approved by the school board by September 2011. There is a one-time revision date in February 2012. A staff meeting will be scheduled to help determine protocols, ie, payment tied to student performance/scores, leadership, extra-duties, and hard-to-fill-positions. The bonus/incentives will be paid out during the 2012 school year.
