HAGERMAN JOINT SCHOOL DISTRICT NO. 233 REGULAR MEETING OF THE SCHOOL BOARD HELD AUGUST 10, 2015

The regular meeting of the Board of Trustees of the Hagerman Joint School District No. 233, Gooding and Twin Falls Counties, Idaho, was convened at 7:00 p.m. on the 10th day of August, 2015, in the Media Center of the Hagerman Jr/Sr High School, Hagerman, Idaho, pursuant to authority provided by ID Section 74-206.

A. CALL TO ORDER

The meeting opened at 7:00 p.m. with Chairman Karl Emerson presiding.

B. ROLL CALL & VISITORS

Present were Trustee Karl Emerson, Trustee Mark Daily, Trustee Chuck Steele, Trustee Monte Osborne and Trustee Angie Lauritzen. Also present were Superintendent Eric Anderson, Principal Mark Kress, and District Clerk Bette Reed.

Visitor was Anna Ray.

C. CONSENT AGENDA

<u>Motion</u> (Lauritzen/Daily) Carried to accept the consent agenda. (Questions-bills from Norco, Western Waste Services, Verizon, Lowe's Building Supply)

D. REPORTS

- 1. Superintendent Eric Anderson:
 - Remarked that Hagerman School has been recognized for high percentage of students (66%) "Go-on-to-College" from the state. The other two schools recognized were Castleford at 83% and Murtaugh at 71%;
 - Will need to expand on last year's Strategic Plan goals. Discussion held on the various student tests and student/school's results and methods to improve;
 - The District did not need to cash out a CD to pay for salaries/accounts payable during the month of July 2015;
 - The Hagerman Alumni Association would like to donate some money to the school and she is inquiring as to the needs of the schools;
 - Some of the events of Flex Days were discussed.

2. Principal Mark Kress:

- State requirement for healthy snacks in vending machines -there is a strict list of foods that can be sold to students. Downside is that students grades 9-12 will leave campus to purchase foods that the vending machines used for fund raising events.
- High School Registration maximize students to take college credit via IEN at reduced costs.
- RTI schedule each teacher will have 4 days a year: no busing, no lunches. A schedule will be posted as to the teacher in attendance to maximize students need for help with particular subjects.
