## REGULAR MEETING OF THE SCHOOL BOARD HELD NOVEMBER 12, 2013

The regular meeting of the Board of Trustees of the Hagerman Joint School District No. 233, Gooding and Twin Falls Counties, Idaho, was convened at 7:00 p.m. on the 8<sup>th</sup> day of November 12, 2013, in the Media Center of the Hagerman Jr/Sr High School, Hagerman, Idaho, pursuant to authority provided by ID Section 33-510.

#### A. CALL TO ORDER

The meeting opened at 7:00p.m. with Chairman Karl Emerson presiding.

### B. ROLL CALL

Present were Chairman Karl Emerson, Vice Chairman Mark Daily, Treasurer Harry DeWolfe, Trustee Kim White and Trustee Chuck Steele. Also present were Superintendent Ty Jones Principal Mark Kress. District Clerk Bette Reed was absent.

### E. REPORTS

- 1. Superintendent Ty Jones:
  - Career Ladder depending on legislature for funding, phase in over 5 years if approved by Education Task Force via State Legislature;
  - Supplemental Levy worksheet handed out to trustees reflecting amounts expended and balances of various categories;
  - Letter in board packet pertaining to students requesting school uniforms (5<sup>th</sup> grade class);
  - Safety inspection conducted with minimal corrective actions noted;
  - Roof costs cost of new roof vs. replacement cost. Opted for a new roof. Either selection will have an out of pocket deduction of \$2,500.

#### 2. Principal Mark Kress:

- Final EOC (End of Course test) for 1<sup>st</sup> trimester;
- Teachers updating EOC's with common core;
- Pay for Performance for discretionary pay
- Trimester 2 scheduling underway;
- Paying of IDLA classes: No choices left for students grades 9-12;
- 8 & 6 Program could result in future enrollment funding concerns.
